## CRIME Teen arrested in Monday shooting

A Philadelphia teenager has been arrested and charged in connection with a shooting Monday on Valley View Drive that sent a man to the hospital.

The teenager, Lemarion Hold-en, 18, 237 Valley View Drive, was arrested and charged with discharging a firearm in the city limits.

Philadelphia Police Chief Eric Lyons said investigators are seeking a second suspect and shooter.

'More arrests are expected and we will release updates when we get them," Lyons said. Lyons said the incident was

reported at about 12:50 p.m. when his office received a report of shots fired on Valley View Drive. Lyons said the call took officers to Holden's residence.

According to Lyons, a male was struck in the foot and was transported by personal vehicle escorted by law enforcement Neshoba General. Lyons said the victim was reported to be in surgery on Tuesday and was expected to be released that evening or Wednesday. Neshoba County Sheriff Eric Clark said deputies responded to the scene and were part of the escort to the hospital. A neighbor's vehicle and residence were struck with bullets from the incident. No injuries were reported by the neighbor, Lyons said.

# Teenage entrepreneurs blend humor with candle creations

Teenage entrepreneurs Jack Butler and Pete Peebles break the mold as high school juniors managing their own candle-making business.

Both 17, Butler, who is homeschooled, collaborates with Peebles, who attends Leake Academy, blending their humor and wit into a promising local business with significant potential for both their business venture and personal growth.

After merging their initials together, the duo arrived at JP Homemade Candles, priding themselves on maintaining a professional product with a touch of teenage charm.

As stated on their website: "When you buy this candle, you are supporting two young men who are Two Hot To Candle."

'We keep our products professional, but our faces funny," Butler said.

The inspiration for their candle business was sparked during a group chat, fueling the entrepreneurial spirit that led them to collectively drive their ideas forward.

"We've always been entrepreneurs just doing things here and there. Growing up I was always reselling stuff," Butler said. "We experimented around,

found a candle that was competitive with major brands, started selling to a couple of friends, and it took off from there."

"We just order 10 to 15 samples at a time to see what we like," Peebles said. "Sometimes we won't pick any scent out of there, or sometimes it may be five, four, it doesn't matter. From there we try to think of a name, and that's a process in and of itself. We usually come back to the first one we thought of.'

Established officially in early 2023 after a successful end to 2022, JP Homemade Candles currently offers a variety of scents like Autumn Days, Sunshine Squeeze, Caribbean Breeze, Coastal Charm, Pineapple Paradise, Light My Love, Oh My Cider, Cozy Daze, Frostbite, and O' Christmas Tree.

"Our best-selling candle overall is probably O' Christmas Tree, but yearround it's Sunshine Squeeze, Autumn Days, and Caribbean Breeze." Peebles said.

Caribbean Breeze was one of their first scents. "Our first ever batch of candles was a completely different wick, jar, and wax, but the scent was the same," Butler said. "Out of the three original scents we tried out, Caribbean Breeze was the one that sold well, so we grew off of that scent until we

brought in some more."

Despite occasional clashes due to their lifelong friendship and knowing how to push each other's buttons, Butler and Peebles leverage their roles effectively, with Butler managing media and marketing and Peebles overseeing the website, spreadsheets, and accounting.

They don't hold back and there is no sugarcoating with them, they said. "We tell it how it is and have figured out our roles.

Their physical work involves ordering supplies, melting wax, adding scents, and pouring candles. After addressing imperfections like sinkholes near the wicks, they choose names and design labels.

Though their marketing approach is simple, they've received community support by gaining a presence in local stores like Kademi and Hospital Gift Shop, pouring candles for MG & Company's signature line, and participating in events like Ham Jam.

They also have engaged in a few exclusive collaborations, and their community involvement extends to fundraisers, with one for the Beta Club raising \$20,000.

"When you are younger, you always see these other successful people and think it's just good luck, but if you just

have an idea, act on it, and keep going no matter if you fail, you will eventually be successful," Peebles said.

Butler added, "Use what you have to vour advantage. Use vour family. friends, age, and story. People would rather buy from a story than a company that's not going to give interaction. With us, people ask about our story and that's how we've gotten the word around town."

Outside of their entrepreneurial journey, Butler enjoys woodworking, basketball, guitar, and 4-H shooting sports, while Peebles enjoys playing golf, football, guitar, and working at Prince Oil.

Peebles plans to major in accounting at Mississippi State, aspiring to work in a bigger city before starting his own private equity firm. Meanwhile, Butler aims to major in business at Freed-Hardeman University in Tennessee, with dreams of owning multiple businesses and engaging in part-time ministry work.

"Business has been great. People ask what our biggest failures are, and I don't think I could even name one," Peebles said.

## Boler named Volunteer of the Year

Jacob Boler, an 11-year forklift driver at Weyerhaeuser, has recently been awarded the company's Volunteer of the Year due to his exceptional work with children in Neshoba County.

He is one of only five employees selected companywide and the sole recipient from the Southeast region. He was selected based on his volunteer activities throughout the year, his dedication to education and youth development, as well as by nominations from co-workers and six different community members.

"He rescues people by loving them," wrote Philip Prince in his nomination. "They know he sees them. They know he cares. They see him work. He challenges people because Jacob isn't satisfied with the status quo. He provides hope and is a role model. Jacob doesn't take it easy on people. He challenges them to strive for excellence.

Boler has gone above and beyond over the years. He founded the nonprofit Kids Over Everything (KOE) in 2009, organizing annual school supply drives, toy drives, and various events for local children.

Boler said his motivation for founding KOE began after noticing a lack of events going on in the area for local kids. He said he wanted to be involved

and start with something small, which ended up being a little dance during Christmas Break at the Neshoba Sportsmans Club in Philadelphia.

"I had no idea the school supply drives would get as big as it did when I first started, Boler said. "It started off with 50 kids, the next year it was 100, then 300, then it got to a point where I was getting 2,500 kids, and we had to start doing the events at the Coliseum.'

Most recently, KOE held its second annual Christmas Toy Drive in December. Boler said the event was an even greater success than the ones before and he plans to have the drive again this year.

"I want to be a positive force for change however I can, whether by making sure kids have gifts to open on Christmas or helping them gain basic life skills," he said. "For many of them, even just knowing there's an adult out there who cares about them is impactful."

Boler said his commitment is not driven by recognition, but it makes him feel good when he has positive interactions with kids who recognize him as the person who generously provides them with school supplies and toys.

Weyerhaeuser has been a big help," he said. "My coworkers have been magnificent. They will go out to Walmart themselves to buy school supplies and toys, and they let me put flyers up so people will donate. When they put the word out, it goes a long way so others will know to help.

Beyond working for Weyerhaeuser and running KOE, Boler is also an assistant basketball coach for the Philadelphia High School boy's team and offers free basketball training at the Church of the Arc at 138 Lakeside Drive.

"When you come to my camp we are going to work hard, we are going to say "yes sir" and no sir", and be respect-ful," he said. "We are going to do all the intangible things that people don't do nowadays. I teach kids when they shake hands to look a man in the eye and give a firm handshake. Simple things like that can take them a long way in life."

Despite the sense of accomplishment and success, he feels this award brings to him, Boler continues to remain focused on making a profound impact on the lives of children and being a positive role model in his community.

## Man arrested for theft at chicken farm

A Forest man has been arrested and charged in connection with taking materials from a Neshoba County chicken farm at Hope.

The man, Bill Hayes, 45, 4506 Langs Mill Road, Forest, was arrested and charged with grand larceny, according to Neshoba County Sheriff Eric Clark

Clark said investigators are working to identify an accomplice and expect more arrests.

More than 1,500 feet of copper wire was taken from a set of four chicken houses off Highway 488 on Feb. 6, Clark said. Clark said Hayes had been

identified as someone who had recently worked for the farmer. He was brought in for questioning on Friday, Feb. 16.

"The local farmer had allowed Hayes to remove scraps from a chicken house that had recently burned," Clark said.

According to Clark, Hayes allegedly returned to the farm and removed over \$7,000 worth of copper wiring.

"The farmer was devastated when he went to use an electric pump in one of the remaining chicken houses,' Clark said. "The loss of power led him to the discovery of the theft."

Specifically, Clark said Hayes and anyone else charged in this case could face charges

related to property or equipment that was damaged when they stole the wiring.

Clark said there is a market for materials and equipment from chicken farms. Last week Clark reported an unrelated theft in which Jerry Lee Higgins, 47, of Walnut Grove, was charged with three counts of grand larceny in connection with at least three reported incidents in Neshoba County where tin roofing for chikcen houses and other materials and equipment were stolen.

## **EDITORIALS** Biden's boxes of influence

If special counsel Robert Hur's report on mishandled boxes of classified documents embarrassed President Biden, whistleblower Tony Bobulinski's congressional testimony must have mortified him.

Mr. Bobulinski, who served as an officer in the U.S. Naval Nuclear Power Training Command, claimed in an opening statement before a joint House hearing Tuesday that "Joe Biden was 'the brand' being sold by the Biden family. His family's foreign influence-peddling operation - from China to Ukraine and elsewhere - sold out to foreign actors who were

seeking to gain influence and access to Joe Biden and the United States government."

A former Hunter Biden business partner, Mr. Bobulinski said Chinese energy firm CEFC infiltrated the Obama White House in 2015 and compromised then-Vice President Biden. Son Hunter was instrumental as "the Biden family's weakest link," he said, drawn in "with the promise of tens of millions of dollars, initially."

Present at several business meetings with the elder Biden in 2017, Mr. Bobulinski asserted that Mr. Biden wasn't simply "a participant" in the influence-peddling scheme, "he was an enabler," and his denials of involvement are lies. As an ongoing congressional impeachment inquiry uncovers the facts, the president enjoys the presumption of innocence.

Meanwhile, the White House is still reeling from Mr. Hur's characterization last week of Mr. Biden as "an elderly man with a poor memory" in explaining his handling of documents — even while the special counsel's conclusion spared the president from prosecution.

Garland on Monday requesting access to documents special counsel investigators found in cardboard boxes scattered among the detritus in Mr. Biden's Delaware garage.

Therein, lawmakers suspect, lies validation that the Bidens profited from their patriarch's proximity to the levers of power. The committee members also requested a transcript of the special counsel's interview with Mr. Biden, seeking to ascertain whether uncomfortable questions were disallowed.

Among the recovered records is a fourpage document dated March 2013 and addressed to Mr. Biden titled, "China Engagement in the Second Term." It was in December 2013, during President Barack Obama's tenure, that Hunter accompanied his father on Air Force Two to Beijing. Days later, he was awarded a director's role in an investment firm funded with Chinese government money, The Wall Street Journal has reported.

Also among the shoddily stored Biden records is a five-page memo titled "U.S. Energy Assistance to Ukraine" from September 2014. The date coincides with Hunter's tenure on the board of Burisma, a Ukrainian energy company that reportedly paid him \$1 million a year. It also coincides with actions the elder Biden took to halt an investigation into allegations of corruption at Burisma. According to House investigators. Hunter raked in as much as \$20 million from China. Ukraine and elsewhere, with few credentials

beyond his Biden name. Embarrassment for President Biden notwithstanding, allegations raised in Mr. Bobulinski's testimony and Mr. Hur's investigation must be resolved for the good of the nation.

## Willis vs. Wade vs. euphemisms

During questioning of Fulton County, Georgia prosecutor Nathan Wade about his "relationship" with District Attorney Fani Willis there was a moment that cut through all the euphemisms we have become accustomed to when it comes to human behavior.

Scott Sadow, an attorney for Donald Trump, who is trying to get an indictment against Trump dismissed for Trump's alleged interference in the 2020 presidential election, received an answer to a question that appeared to surprise him. Asked about his "relationship" with Willis, Wade said"do you mean intercourse?" Sadow said he wasn't going to use that word, but since Wade brought it up, then yes, that's what he meant.

It was a classic example of how euphemisms are increasingly used to soften the meaning of questionable behavior.

A forceful Willis tried to obfuscate her relationship with Wade, even calling him at one point a "Southern gentleman." But in an earlier court filing, she admitted to an affair (meaning sex) with Wade, who she put on the payroll as part of her Trump prosecution team.

Radio host Dr. Laura Schlessinger receives calls from women who speak of living with their boyfriends.

"In other words," she said, "you're shacking up."

One woman replied, "I wouldn't put it that way.' Schlessinger then asked,

"How would you put it?" woman had no The answer.

Lying doesn't always bring the consequences it once did, even when witnesses take an oath to tell the truth. It is more than fishy that Wade and Willis exchanged cash

So many descriptions of human behavior have been modified or changed to gloss over their real meaning. In part, I think, it is to avoid judgment which can lead to a change in behavior that benefits individuals and the wider culture. Failing to identify certain behavior for what it is can have the effect of legitimizing that behavior in the eyes of people who are engaging in it and in the wider culture that refuses to accept a standard defining

right and wrong. How many speak of cheating on one's spouse, as Wade is alleged to have done, as "adultery"? Today's preferred description is "a romantic relationship." Going on 'vacation" with a woman not your wife or a man not your husband is now considered as legitimate as a married couple enjoying a similar experience.

Could we also stop saying "boyfriend" and "girlfriend" when speaking of adults? These are not dating teenagers. They are mature people who have presumably been exposed to what used to be called the right way to live, but who have chosen another way.

Lying doesn't always

Russia's traditional resentments and insecurities, to a determinedly anti-Western view that draws on Slavophile thought. Wade refused to say where he keeps his cash, but suggested some of it might be under his pillow. Willis said she once paid Wade \$2,500 in cash that came from her pocketbook. Who carries around that kind of money? Wade even obfuscated on whether he used a credit card and how he was reimbursed for part of his expenditures when he and Willis traveled together. Who doesn't keep receipts, especially for tax purposes? Will the IRS investigate?

### **FLASHBACKS**

#### February 25, 1944

Visions of a new County Court House with ample space for all the needs of the county government and various Federal Government agencies with a modern jail comprising the top story were presented to the members of the Rotary Club Monday by T.A. Webb, chairman of Philadelphia's Post War Planning Committee.

It really isn't news - not to Neshoba County farmers - but many county roads are impassable due to continued rains and thousands upon thousands of pounds of milk being produced by the farmers is going to waste, to say nothing of other economic losses entailed by present road conditions.

#### February 25, 1954

One of Neshoba County's R.C. Peebles, disaster chairman of the Neshoba County Chapter, American Red Cross, reports a survey has been made of the damage done by recent tornadoes in the county.

The streamlined "Little Rebels" of the Gulf, Mobile and Ohio Railroad were removed from service in Mississippi last night after almost 20 years of continuous service. The preference of passengers for highway travel and a mounting deficit in operating the two trains last year were the principal reasons for withdrawing them.

February 27, 1964 A major American furni-

What would he say about those on the right who seem to be confused about the same question?

Over the last few days, Donald Trump told a rally about how he'd supposedly warned the leader of a NATO nation that he'd encourage the Russians "to do whatever the hell they want" against countries that weren't spending enough on defense, while the former Fox News personality Tucker Carlson broadcast videos from Moscow praising its grocery stores and subways as superior to those in the United States.

For its part, the Republican-controlled House of Representatives is refusing to approve another tranche of aid to Ukraine as it runs short of artillery shells in a defensive war against Russia.

What's notable about all of this is that people who, in other contexts, are fierce about the need to defend West-ern civilization are unenthusiastic about a core institution of the modern West - namely, NATO — and feel little urgency about checking the aggression of a Russia that is an avowed and long-time civilizational adversary of the West.

There are legitimate policy disagreements about NATO and the Ukraine war, but there shouldn't be any doubt about the larger significance of Vladimir Putin's challenge to the West's interests, values and resolve.

In his classic book "The Clash of Civilizations," the late social scientist Samuel Huntington wrote of an

#### significance of Vladimir Putin's challenge to the West's interests, values and resolve.

"Orthodox civilization, centered in Russia and separate from Western Christendom as a result of its Byzantine parentage, distinct religion, 200 years of Tatar rule, bureaucratic despotism, and limited exposure to the Renaissance, Reformation, Enlightenment, and other central Western experiences.'

There's some ambiguity about this, as Russia has always had a conflicted relationship with the West. In the early 18th Century, Peter the Great grabbed his country by the neck and forced it to adopt more Western ways. He built St. Petersburg as a Europeanstyle city, and pursued a dizzying array of military, administrative, educational, legal and cultural reforms. Peter's mode of Westernizing, though, was profoundly Russian — an exalted ruler wielding brutish, centralized power.

It also caused an anti-Western reaction — as the historian Orlando Figes points out in his book "The Story of Russia" the so-called among Slavophiles who believed Russia had turned away from what should be its true, distinctive path.

For his part, Putin made a nod toward the Petrine tradition initially upon taking power. He stated his ambition to become "part of western European culture." But this gave way, under the pressure of NATO expansion and of

## **Refuge Roundup raising money for ministry**

The Refuge of MS ministry for adults with special needs is gearing up for its annual Refuge Roundup event at the Coliseum on March 1, from 10 a.m. to 2 p.m.

More than just a fundraiser, this event serves as an opportunity to enlighten families about the diverse care options offered by The Refuge of MS for individuals with disabilities beyond their school years.

Formerly known as The

Refuge Mock Rodeo, this year's event has been renamed Refuge Roundup reflecting its welcoming and inclusive nature.

"Last year we were rounding up a lot, whether it was getting volunteers or just rounding up friends who came," Refuge Director Brooke Crenshaw said. "It definitely felt like a roundup in itself, but it made for a fun day. We wanted it to be a catchy name to where others can know it's an event their child can have fun at, feel included in, and accommodate them well."

This event is designed for individuals who are intellectually and/or physically disabled and promises a day filled with unique experiences, with a primary highlight being horse riding.

Participants from the Refuge, local schools, as well as nearby friends and families will have the chance to engage in a horse riding experience, complemented by a petting zoo, face painting, and other hands-on educational activities like the MS Children's Science Museum.

The petting zoo will feature an array of animals such as goats, sheep, miniature horses, a big horse, a miniature zebu cow, a miniature donkey, pigs, chickens, and rabbits.

"We want our friends to experience riding a horse with no pressure and at their own pace," Crenshaw said. "If they are not comfortable riding a horse, we will have some off to the side they can pet."

The event will also host a mounted patrol unit and volunteers who are generously bringing their horses, providing the opportunity for participants to ride either solo or with assistance, using adaptive saddles for a safe and enjoyable experience.

For those in wheelchairs, the Coliseum ensures accessibility with an elevator to the packed dirt floor, and a specially designed wheelchair ramp, courtesy of East Central's carpentry program, will help aid in getting individuals on and off horses.

"We will also utilize the arena's first aid station as a room that individuals can use

for privacy, especially if they need some care, and we will have a hover lift on site to allow individuals in a wheelchair to have that accessibility," Crenshaw said. "Families and teachers are asked to bring their own hoyer lift sling."

### Getting the Message/Rev. Chris Shelton

God's gracious gift of grace

In Revelation 1:4, we see that the book of Revelation is a letter to seven churches in Asia. Seven is the favorite symbolic number in the book which is full of symbolic language. It signifies the idea of completeness or perfection. So, the seven churches, though they literally existed in the first century, represent the church in all ages. The letter, then, is meant for us, for all Christians.

John begins the letter with the salutation, "grace and peace to you." This is not a perfunctory or superficial greeting. The Christian life is lived hand to mouth from fresh infusions of grace from God. A Christian is converted by grace and continues to live by grace. All we have is by God's gracious gift of grace.

Grace is the unmerited favor of God. The book of Revelation shows us two entirely different scenes. The scenes of heaven show us a realm where all there glorify God and delight in being in the presence of God. The scenes of earth show us a realm where God is not glorified by men. Redemption is the power of God to turn sinful, rebellious man back to the praise and glory of God.

Peace flows from God's grace. We receive peace with God through the blood of Christ cleansing us from all sin. We have the inward peace of God through walking with God, knowing that Christ has made us children of God.

What we see in the beginning of this letter is how willing God is to pour out grace and peace to his people. The book of Revelation will show the tribulations Christians should expect to encounter in this world. But right at the beginning, God wants his people to know that they are blessed and that he will supply all their needs in Christ Jesus.

There is a trinitarian promise of grace and peace that John pronounces in verses 4 and 5. He begins with, "Grace to you and peace from him who is and who was and who is to come." This represents God the Father's promise as the all-sufficient God to bless his redeemed people.

God appeared to Moses in the burning bush and pronounced his name as "I am," meaning he exists in and of himself eternally. A fire needs something to consume or it will die out. But the burning bush was not consumed. As such it represents God, who is dependent on noth-

ing or no one. He has always been and always will be the eternal, unchangeable,

infinite God. Grace and peace come from our Father in heaven. It also comes from "the seven spirits which are before his throne." Again, the number seven is completeness, so the seven spirits aren't created things, but represent the perfection of the Holy Spirit. The Holy Spirit is the gift of God, who is poured out from the throne of God after Christ ascended into heaven.

The New Testament makes clear that the difference in men is essentially those who have the Spirit of God and those who do not. The Spirit makes us alive in Christ. We are taught as Christians to live in step with the Spirit of God. Jesus says, "Blessed are those who have ears to hear what the Spirit says to the church." This means we must apply the words of Scripture to our lives.

In verse 5, grace and peace are from "Jesus Christ, the faithful witness, the firstborn form the dead, and the ruler of the kings of the earth." Christ is the faithful prophet of God. We can trust what he says. He came to bring us to God. The Father says, "Listen to him." He is the firstborn from the dead.

Christ, as the eternal Son, had no beginning, but his resurrection begins the new creation, reconciling all things in heaven and earth to God. His resurrection promises life with God for all who are united to him. All our hope is in Him. That he is the ruler of all kings is good news. His kingdom prevails over the power of Satan. Whatever his people must endure in their short lives now on earth, they have a place in the kingdom of God.

We learn in these verses how willing God is to give us the grace we need. Father, Son, and Holy Spirit promise to sustain souls who believe. From the first to last, we are in need of God's aid. Pray continually for his grace and peace. God commands us to pray and promises to hear us in Christ. Grace and peace are rich treasures God is pleased to give to needy souls.


