6 arrested in Valley View drive-by

Six young men including two juveniles have been arrested in connection with a drive-by shooting on Valley View Drive last week that left one man injured. Three men were arrested on Feb. 21, after being connected to the car involved in the shoot-

into custody on Cherry Avenue.


Additional information led to the arrest of two juveniles charged as adults, Damari Rush, 16, and Abraveon Robinson, 17, both facing drive-by shooting charges, according to Lyons.

Both juveniles were taken into custody at their residence. Rush was picked up at Pendelton Square apartments on Feb. 22, and Robinson at 277 Northwest Street the following after-

"It is believed that all five of these men were inside the same vehicle and targeted an individual at a residence on the 500 block of Valley View Drive," Lyons said.

Blissful balloon artist finds success with new business

Ashley Smith, a talented balloon artist and the creative force behind Pure Bliss Balloons, has found success after launching her business just over a year ago around Valentine's Day.

Now juggling her roles as a nurse, wife to Michael Smith, and mom to Charlie and Mary Claire, she finds joy in transforming her passion for balloon art into a blossoming business.

Smith said the smiles on her customers' faces and being nicknamed "the balloon lady" by many kids help keep her motivated and entertained.

"My daughter loves when I do balloons for her, and I have little clients that get excited when I walk in with my big bag of balloons," she said. "It really makes me happy to see them happy over balloons."

The name "Pure Bliss" was a natural choice for Smith and encapsulates one of her favorite sayings that reflect her

view of life.

"Life is just pure bliss, everything is great," she exclaimed.

Smith's journey into balloon artistry began by first making balloons for her children's and friend's birthday parties, coupled with a long-standing desire to be a party decorator.

After being encouraged by her husband to start a Facebook page, the response exceeded her expectations, leading to a surge in balloon bouquet orders through social media and word of mouth.

Soon, Smith found herself decorating events for schools, weddings, and even for downtown businesses when Dolly Parton headlined at the Ellis Theater last year.

"I've always been a crafty person," she said. "There is a lot of thought, time, critiquing, and planning that goes into balloons, and it's way more to it than just throwing balloons together."

Smith draws inspiration from watch-

ing YouTube videos, scrolling through Pinterest, and using her innate creativity with her own personal twist to designs, allowing for confidence to surpass client expectations for any celebration

"My twist to balloon art is the little extra details," she said. "It's the small things that matter."

After potential clients reach out via Facebook, text, or call, the planning process including date, time, location, and theme discussions begin. Smith then sends mockups for approval and prints the balloons a day before the event to avoid mishaps like balloons popping the day of.

Her balloon orders are often sourced online, and she takes pride in her extensive color palette, having nearly stockpiled every shade imaginable. Balloons, she believes, offer endless possibilities of various themes and interests.

"The good thing about balloons is you can make them anything you want

them to be," she said.

Holidays and school graduations mark peak seasons for her business, and her creativity has even extended to charitable efforts, such as donating balloons for a Make-A-Wish event at the country club. For Smith, each event holds a special place in her heart.

Although she admits that her commitment to accepting requests may sometimes lead to overbooking, Smith remains steadfast, having scaled back to one or two setups on weekends.

"I have trouble telling people no," she said. "But no matter how many times I overbook myself, I still make it work"

The joy Ashley Smith spreads through her balloon art is evident in every event she undertakes. Her advice for aspiring creatives in the balloon business or any venture is simple: be creative, add your personal touch, and persevere even if success doesn't come instantly.

Sheriff seeks mobile app to fight crime

A mobile app that provides citizens with access to the sex offender registry, information on wanted criminals, resources for crime victims, tip submissions and more is being proposed by Neshoba County Sheriff Eric Clark

Clark first introduced the idea for the app to the Board of Supervisors in November, sparking ongoing discussions, without any action so far.

The app would allow the Sheriff's Department to send push notifications about road closures, accidents, and weather alerts. Users could also register complaints or compliments related to their interactions with deputies.

The mobile app that Clark favors, branded as the Sheriff's App, also features access to the county jail's inmate roster, allowing users to schedule visitations and contribute commissary funds for inmates, and would establish a voluntary registry for home and business owners with security cameras in Neshoba County providing the Sheriff's Office with contacts who may possess footage relevant to crimes, suspicious vehicles or suspects.

According to Clark, the Sheriff's App could be funded from monies exceeding \$11,000 left over from the Ally Telecom grant, along with additional donations to

On Aug. 21, 2023, and Sept. 27, 2023, it was reported to the Neshoba County Sheriff's Office that copper wire was stolen from poles in the Burnside community and along Marty Stuart Drive at Arlington.

Jones was arrested by Neshoba County deputies and charged with grand larceny.

During the investigation, it was determined that the group used climbing spikes to climb the poles and cut the wires.

They used mule tape to tie to the wire and pull it down to the ground.

The group would pile wire

and then return later to load it.

Neshoba County deputies located wire trimmings in an old dirt pit on Blackjack Road. The copper was reportedly sold to a scrap yard in the Jackson

The suspects are all awaiting a bond hearing in Leake County, according to Clark.

Once released from Leake County, he said they will be transferred to Neshoba County and face grand larceny charges.

They are also suspects in copper wire thefts in Attala, Scott, and Pearl River counties, Clark said.





Philadelphia aldermen adopt new public records policy

A new Public Records Policy for the city of Philadelphia has been approved by aldermen, which should make obtaining

records an easier process for both the city and citizens, officials said. This new policy aligns with the state law allowing public records to be accessible for inspection and copy-

ing during normal business hours, Monday through Friday, 8 a.m. to 5 p.m. Individuals seeking to inspect or copy public records of the city of Philadelphia should submit a written request using the city request form, or via letter, fax, or email addressed to the

request include the requester's name, address, contact information, identification of the public records, and the preferred date and time for the request.

If the requester prefers copies instead of inspection, they should specify and arrange payment or a deposit for copies at a rate of \$0.50 cents per page for standard photocopies. The cost of searching, reviewing, and redacting exempt informa-tion will be based on the hourly rate of the lowest-paid city employee qualified for the task, according to state

Requests will processed in the order that allows the most efficient handling within seven business days, and requesters must claim or review the assembled records within 30 days

of notification that the records are available.

The process for requesting electronic public records is the same as for requesting paper records, and a request form is also available at the public records officer's office and online at philadelphiathecity.com, officials

"This will help everybody and make the process a lot easier," said City Attorney Robert Lee Thomas.

For those requesting access to public records or needing assistance with requests, contact the City Clerk of The City of Philadelphia.

Lyons said the incident was reported at about 12:50 p.m. when PPD received a report of shots fired on Valley View Drive. Lyons said the call took officers to Holden's residence.

According to Lyons, a 22year-old male was struck in the foot and was transported by personal vehicle escorted by law enforcement to Neshoba Gener-

"The male victim has since been released after surgery and is back home," Lyons said. He noted the victim is not believed to be the target of the shooting.

Neshoba County Sheriff Eric Clark said deputies responded to the scene and were part of the escort to the hospital.

A neighbor's vehicle and residence were struck with bullets. No injuries were reported by the neighbor, Lyons said.

Officers made contact with Holden who was also at the residence where the shooting occurred and recovered a gun that was used to shoot back at the drive-by vehicle that struck a neighbor's truck.

Officers were able to obtain a vehicle description of the drive-by vehicle and were able to identify the tag number and owner of the vehicle using Flock cameras in the city, Lyons said.

On Feb. 21, officers were able to locate the vehicle on Cherry Avenue where Boyd, Burch and Green were found inside the vehicle and were taken into custody.

Lyons said on Tuesday bond had not been set.

Trump trounces Haley at home

There's a time to turn the page, but it's only when the story is finished. That's the message from South Carolina's Republican primary voters, who showed they're no more ready to move on from former President Donald Trump than he is willing to depart from a script that concludes with a return to the White House.

Mr. Trump won Saturday's Palmetto State presidential primary with a comfortable 60% share of votes among a strong Republican turnout. Despite her popularity while serving as South Carolina's governor and then U.S. ambassador to the United Nations, fellow contender Nikki Haley mustered just 40% — despite generous help from Democrats allowed to vote in the state's open primary.

Making the most of her youthful looks, competent red-state helmsmanship and solid diplomatic credentials, Ms. Haley has outlasted all GOP rivals except the former president. Ms. Haley had counted on a wall-to-wall TV ad campaign to convince state Republicans that it's time to "turn the page" on the Trump era. It's no reflection on her qualifications that in South Carolina, where a sense of right and wrong still matters, voters disagreed.

Leading the list of wrongs that Americans charge to President Biden's faulty leadership is a border policy that has flooded the nation with millions of illegal immigrants. According to an Edison Research exit poll, the dysfunctional southern border topped the priorities list in South Carolina, named as most pressing by 37% of primary voters. The economy ranked second at 33%, and foreign policy followed at 13%.

Judging from the enthusiasm of pro-Trump crowds, South Carolinians were equally driven by their sense of injustice heaped upon the former president in Democratic-controlled strongholds. Voters reckon that abandoning Mr. Trump to the depredations of his enemies would ensure that no Republican challenger will be spared similarly rough treatment in the

The list of insults to justice is extensive: New York courts entertaining novel business-law charges that can name no victim and innuendo-laden sexual assault and defamation lawsuits that stand to cost the Republican front-runner half a billion dollars. In the Empire State, an outlandish federal campaign-finance case also looms.

In Washington, Mr. Trump faces charges for urging Americans disturbed by 2020 election irregularities to display their displeasure by protesting "peacefully and patriotically." Another trial awaits for getting crossways with presidential recordkeepers. In Georgia, he is confronted with racketeering allegations for asking election authorities to "find" more 2020 votes. On all fronts, the Democratic Party's bag of legal dirty tricks threatens to bankrupt and imprison Mr. Biden's likely Election Day opponent.

Meanwhile, Ms. Haley vows to fight on, reportedly preparing seven-figure ad buys leading up to Super Tuesday on March 5, when Republicans will cast primary ballots in 15 states and one U.S. territory. Barring a startling breakthrough, she will fall too far behind the Trump juggernaut to have a realistic expectation of securing the party's nomination.

Mr. Trump's "make America great again" script has no role for the South Carolina runner-up. Ultimately, it's up to voters whether to decide whether follow Mr. Trump's narrative or, as Ms. Haley urges, to "turn the page."

Trump promises to protect Christians

Speaking to an audience of devoted fans at the National Religious Broadcasters Convention in Nashville last Friday, Donald Trump said if reelected president he will "... create a new federal task force on fighting anti-Christian bias. ... Its mission will be to investigate all forms of illegal discrimination, harassment and persecution against Christians in America.

Dr. Robert Jeffress, pastor of the mega First Baptist Church in Dallas, said Trump's speech "was the most powerfully pro-Christian speech I've ever heard from any president. He will win the Christian vote in a landslide!"

From the beginning of the nation, presidents and candidates have used religious language and quoted Scripture to influence especially conservative Christians to vote for them and back their policies. Not all have meant what they said, or followed through in their personal and political lives in ways that reflected the faith they claimed to hold.

Trump also repeated his assertion that the "radical left..." want(s)to tear down crosses where they can, and cover them up with social justice flags," adding, "But no one will be touching the cross of Christ under the Trump administration, I swear to you." I always thought crosses were a good defense against vampires until someone told me there are no vampires in America. I replied, "see, the crosses are working!'

But seriously, folks. Evangelical Christians who believe government is necessary to defend their faith are getting their marching orders from somewhere other than

the Scriptures they claim to revere.

For those who need a reminder on what should be expected from the unbelieving world, here are some verses that might help sharpen their

Paul, an Apostle of Jesus, suffered numerous persecutions because of his faith. These included beatings, shipwrecks, hunger, jail and eventually death. He responded: " My persecutions and sufferings that happened to me ... I endured; yet from them all the Lord rescued me. Indeed, all who desire to live a godly life in Jesus Christ will be persecuted." (2 Timothy 3:11-12) All means all

Jesus, Himself, told his disciples to expect persecution: 'If you were of the world, the world would love you as its own; but because you are not of the world, but I chose you out of the world, therefore the world hates you. Remember the word that I said to you: 'A servant is not greater than his master.' If they persecuted me, they will also persecute you...
"(John 15;19-20)

Elsewhere, Matthew records Jesus saying: "Blessed are those who are persecuted for righteousness' sake, for theirs is the kingdom of heav-

Blessed are you when others revile you and persecute you and utter all kinds of evil against vou falsely on my account. Rejoice and be glad, for your reward is great in heaven, for so they persecuted the prophets who were before you." (Matthew 5:10-12)

The key words here are "for righteousness' sake" and "falsely." If one is persecuted for saying and doing stupid things the persecution is on them.

Christians all over the world have suffered harsh persecution. American Christians think they are being persecuted for things that would be considered trivial by those who have experienced imprisonment, even death, for their

Surveys show that many Americans, especially the young, have stopped attending formal worship services because they see them as having been tainted by poisonous political agendas. People of strong faith who have not made a bargain with the political devils of our day don't need secular government to defend them. Like those Christians of the past they (and some in the present like Russian patriot Alexei Navalny) should stand strong for their faith, living it out in the world in obedience to the one they call "Lord." If they do that, the world just might stand back and marvel.

The campaign against Donald Trump

Donald Trump has a \$355 million judgment against him. and we're just getting started.

The judgment in the civil fraud case, which reaches \$450 million including prejudgment interest, is the handiwork of an elected Democratic judge in a case brought by an elected Democratic prosecutor who pledged to pursue Trump in her election campaign.

The prosecutor, New York Attorney General Letitia James, wielded an incredibly broad statute meant to target consumer fraud. Executive Law 63(12) doesn't require any finding of intent to commit fraud or illegality, or require actual victims. The judge in the case, Arthur Engoron, said it didn't even matter whether Trump's exaggerated valuations of his assets were relied on by any-

It is, in short, the magic bullet of anti-fraud statutes, and the perfect weapon in the hands of a politically motivated prosecutor looking for any reason to nail one specific person she and all her supporters passionately hate.

The shockingly extravagant judgment against Trump isn't for damages - since there were, ahem, no damages — but supposedly to "disgorge" his "ill-gotten gains."

In harassing lawsuits or prosecutions, it is often said that the process — in other words, the time and money spent fighting the case — is the punishment. That's certainly true of Trump, whose campaign coffers have been drained by legal fees and whose schedule has been clogged with court dates. But the punishment is also the punishment.

It is a rejection of the Anglo-American legal tradition as it has developed over the centuries to enshrine neutrality and fair play in favor of something that is more personalized and illiberal.

On top of the civil fraud case, Trump has been hit by \$5 million and \$83.3 million verdicts in the two E. Jean Carroll cases. Former prosecutor Andy McCarthy notes that the rules in such cases are that the defendant "has to post the amount of the judgment, plus interest, in order to assure the court that the appeal is not simply for purposes of delay, and that the defendant will pay up if he loses." That means Trump will have to pony up half a billion dollars merely to appeal.

This is before Manhattan District Attorney Alvin Bragg comes in with his criminal case, wherein the elected Democratic prosecutor has bootstrapped what should, at most, be a misdemeanor involving hush money paid to a porn star into 34 felony counts.

Bragg's fraud case, in what's becoming a theme, doesn't allege anyone actually being defrauded, and was brought only after Bragg was criticized by allies for taking a pass on charges that, to quote Abraham Lincoln, are "as thin as the homeopathic soup that was made by boiling the shadow of a pigeon that had starved to death."

"Lock her up" was an unworthy slogan directed at Hillary Clinton back in 2016. Now, Trump's enemies have seen and raised that sentiment. They are moving to destroy Trump's business, drain his resources, blacken his reputation, sink his presidential campaign and, if they can, lock him up — and literally, not figuratively.

What's happening in New York — and is being replicated at the federal level and in Georgia in the 2020 election cases — is law as blood lust. It is a rejection of the Anglo-American legal tradition as it has developed over the centuries to enshrine neutrality and fair play in favor of something that is more personalized and illiberal.

These prosecutors are acting as if they consider the famous speech by then-attorney general and future Supreme Court Justice Robert Jackson not as a warning, but a roadmap. He called "the most dangerous power of the prosecutor" that "he will pick people that he thinks he should get, rather than pick cases that need to be prosecuted." Given the variety of laws on the books, Jackson explained, "A prosecutor stands a fair chance of finding at least a technical violation of some act on the part of almost anyone." Then it becomes "a question of picking the man and searching the law books, or putting investigators to work, to pin some offense on him."

That Donald Trump is the man in question doesn't make this phenomenon any less disgraceful or un-American.





The Lord's Day

In Revelation 1:10, the apostle John says, "I was in the Spirit on the Lord's Day." In the Spirit means under the influence of the Holy Spirit. The Spirit was in John in a special way; to give him the Lord's prophetic word, which we have in the book of Revelation.

This special visitation of the Spirit came on the Lord's Day. The Lord's Day is the day the Lord Jesus Christ rose from the dead, the first day of the week. The Christian church observes the 4th commandment, to honor the Sabbath day, on the 1st day of the week because

it represents the day of salvation.

Psalm 118 says, "This is the day the
Lord has made. Let us rejoice and be glad in it." The "day the Lord has made," is a prophetic reference to the day of salvation Christ has accomplished by his death and resurrection. We commemorate that day when we gather together on the Lord's Day to worship God in the name of our Lord Jesus

In Revelation 1:5, John tells us that Christ has "freed us from our sins by his blood." After this in verse 7, John speaks of the Lord returning in glory and judgment. Because we are freed from our sins, we are to long for Christ's appearing in glory. This is called the Day of the Lord.

The Lord's Day and the coming Day of the Lord in glory are inseparably connected. Paul said about the Lord's Supper: "As often as you eat the bread and drink the cup, you proclaim the Lord's death until he comes." The Apostle's emphasized that longing for the Lord's coming, the Day of the Lord, was an essential element of our faith.

Paul told the Corinthian Church he was thankful for their riches in Christ as they "wait for his day." Paul told the Philippian Church, "He who began a good work in you will bring it to completion at the day of Jesus Christ." And there are other examples of this we see in their writings.

We don't tend to long for Christ's appearing as we should and part of that is how we view the Lord's Day. Sunday isn't just about going to church. It is worshipping in view of Christ's salvation and anticipating his coming in glory.

Richard Sibbes said: "Since there is such a day as the Lord's coming, let us

make much of the day the Lord has left us. What is that day? It is the Lord's Day. He appointed that day for his honor and glory. We become more acquainted with Christ on this day because the Spirit especially blesses Christ to us in worship. Do you want to hear, 'Come ye blessed by my Father into the kingdom prepared for you?' Then worship on the Lord's Day longing for Christ's appearing."

A solemn reason for anticipating the Lord's coming is that he will come in judgment. There is an allusion to this in Revelation 1:10-11. After he hears a loud voice like a trumpet, John is directed to write down what he will see. The trumpet emphasizes the authority of the Lord's word.

The law was given to Moses with a trumpet blast. In Jeremiah 6, the Lord tells a rebellious Israel that he sent prophets for them to "listen to the sound of the trumpet," but they wouldn't listen. The prophets warned them to listen and apply the word of God, but they did not. The word of Christ that John was to write down is to go to the churches (verse 11).

This word is for the church in all generations until Christ returns. The Lord tells us we need to have ears to hear what the Spirit says to the church. Paul tells us that Christ's return will be with a trumpet blast. Then the day of salvation will be over. The period between the proclamation of the gospel and the trumpet on the last day is the time to make our salvation sure.

The last trumpet is from God. It is not in the sinner's choice whether to appear before God or not. We must all appear before the judgment seat of Christ. The word God gives to us is not an idle word, it is our very life. But it is a gracious word from a gracious Lord.

Make the Lord's Day the most important day of the week. The Lord gives us the Lord's Day to bless us and keep us. The Lord's Day isn't just another day. It is preparation for the day of the Lord. So let us draw near to the Lord, and all the more as that last day approaches.

In large, heavy pot or dutch oven cook bacon over medium heat until fat is rendered, about 5 minutes. Add onions and cook, stirring occasionally, until translucent, about 4 minutes. Stir in the garlic and cook about 1 minute. Add broth, tomatoes, ketchup, Worcestershire, and chili powder. Stir in the beans, turn heat to high, and bring to a boil. Adjust the heat to gently simmer, add and beer, cook minutes. Season with salt and pepper.

While soup cooks, wash, dry, and pick off thick stems from the cilantro, then coarsely chop. After soup simmers 10 minutes, add cilantro and cook about 5 more minutes. Turn off heat and stir in lime juice.

Serve with garnishes.
